A disposal rental will be charged for each barrel of Produced <u>Water disposed of in</u> the easement well(s), regardless of whether the Produced Water was produced onlease or off-lease. Disposal Rent is based on whether operation of Salt Water Disposal is Grantee's "Primary Business," defined herein as transportation, movement, and/or disposal of produced water generates 50% or greater of Grantee's annual gross revenues.
