It is understood that the point of diversion, the place of use, the purpose of use, and the amount to be diverted as permitted under the Water Easement being assigned must be the same as permitted by the New Mexico State Engineer, and that neither the Assignor nor the Assignee shall change these without first obtaining the consent of the Commissioner and the Office of the State Engineer. It is further agreed that failure to comply with these requirements shall <i>ipso facto</i> render this Assignment null and void.
