## APPLICATION TO CONVERT STATE TRUST LAND

- 1. A soil and land capability map indicating the soil and land capability delineations based on the standard soil surveys published by the U.S. Department of Agriculture Natural Resource Conservation Service and with a scale of not less than four inches to one mile but not exceeding eight inches to one mile.
- 2. A proposed cropping system indicating the kind of crops to be planted and the sequence of rotation, if any.
- 3. The following statement from an acceptable authority (Natural Resource Conservation Service, State Engineer, County Extension Service, professional hydrologist or geologist):

I, \_\_\_\_\_\_, verify that there exists or could exist a sufficient quantity of water to insure the sustained use and proper management of the agricultural land and that the quality of the water is such that its use will not be detrimental to the land.
