



RIGHT OF WAY OR BILLBOARD REISSUE AFFIRMATION

This form is applicable to the reissuance of certain types of rights of way and permits where there has not been, and will not be, any change to the use or footprint of the authorized activity under the relevant instrument. The NMSLO has established a more streamlined process for reissuance applications that fall within this category. This form is to be used by current grantees and permittees to request simplified processing for their reissue applications.

For rights of way, pursuant to NMAC 19.2.10.25, or under the general authority of the Commissioner of Public Lands in the case of billboards, applicant hereby requests a reissue of NMSLO right of way number _____, or billboard permit number _____.

The undersigned Applicant swears and affirms the following:

1. My name is _____. I am the applicant for reissuance of this right of way or billboard permit on behalf of _____. I attest that I have the authority to execute this document on behalf of the company noted above.
2. This affirmation¹ is being submitted along with the appropriate application and fees for the following (check the applicable box):
 - a. Right of way for an existing road ☐
 - b. Right of way for an existing electrical line (Under 115 kV) ☐
 - c. Right of way for an existing telecommunication line ☐
 - d. Right of way for an existing fresh water pipeline (TDS concentration of less than 1,000 milligrams per liter (mg/L)) ☐

3. There is no change in the previously approved path of the right of way, or the location of the billboard.¹

4. There is no change in the status, including, but not limited to the permitted use, authorized improvements (if applicable), or approved footprint of the existing right of way/billboard (including width and any staging areas).
5. There is no change in the use of the right of way. The right of way is currently being used for the permitted use of _____ and will continue to be used solely for the same use.
6. Applicant affirms that it is in compliance with all terms of the current right of way or billboard permit.
7. Applicant has read and understands the Cultural Properties Protection Rule, 19.2.24.9 NMAC, and will abide by its terms.
8. No new surface disturbance will result from the reissue of the right of way.² (If new ground disturbance is planned, applications shall be processed with normal processing)

Notes:

1. Current photos at the beginning and end of route must be provided along with this affirmation. Applicants for billboards must provide a current photo from the nearest roadway clearly showing the entire billboard face.
2. The NMSLO Cultural Resources Office must be notified of any inadvertent new surface disturbance immediately by email with as much detail as possible at (CROinfo@nmslo.gov).
3. Rights-of-Way shape files are required as part of every application for reissue and must be available when requested.
4. Billboard reissue applications must provide GIS Coordinates in decimal format.
